JJBIHL Ethics Policy 3.7-3.8 Academic Year 2021 -2022

Students and (Hybrid Classroom) Learning Centers

Students and Hybrid Classrooms acceptance and admission into JJBIHL, it is understood and otherwise implied that students agree in spirit and principle to serve Christ, the local Church, and JJBIHL in such a way as to bring credit upon all and in no way to bring reproach upon any. Students agree to abstain from all appearances of evil (1Thessalonians. 5:22); to separate themselves from evil situations; to do their best to live an upright and moral life (Job 1:8); and to always endeavor to live up to high standards of the call to service (1 Timothy 3: 1-7).

- (a) In no instance should students or hybrids make statements or transmit electronic media in negative presentations about JJBIHL. Any grievances or concerns should be appropriately referred to the Dean of Academics in fairness by teleconference. A resolution will be communicated in writing or teleconference. There is a zero-tolerance policy for making negative comments against JJBIHL regardless of status and position within the school. Students will be automatically withdrawn, and all others will be permanently dismissed/separated from JJBIHL.
- **(b)** Students are expected to follow JJBIHL's registration, orientation, academic and operational policies set forth by this institution annually.
- **(c)** JJBIHL is its own autonomous institution; free from interference, from any denominations, associations, organizations, and/or other postsecondary institutions. No student/hybrid/center, person or individual shall infringe upon JJBIHL's Academic Freedom and Rights to have its own self identity as any other postsecondary institution.
- **(d)** Students/Hybrids/Centers are expected to follow school policies by communicating with the appropriate divisions of the Institution for student and staff services.
- **(e)** Students/Hybrids, persons or individuals understands that JJBIHL's Code of Ethics has a zero-tolerance policy for making negative or misleading comments against JJBIHL regardless of status and position within the school. Students will be permanently dismissed from JJBIHL.
- **(f)** JJBIHL reserves the right to make any/all changes to its policies, rules, and regulations as may be deemed necessary and appropriate at any time by the governing board and president of JJBIHL.
